Discussion / Action item Water Company meeting update regarding fire hydrant: Bill Hamilton reported that the lawyer for the Martindale Water Co. has insisted that the fire hydrant must be called a "Fancy Flush Valve" in future, as it is not an actual fire hydrant. The Water Co. has backed off the requirement that the water line be tied back around the property to River Rd. The Water Co. voted to help pay for the difference between the 2" flush valve and the upgrade to a Fancy Flush Valve.

Discussion / Action item Grant opportunities for building new fire house: Richard Salmon reported that Anita Miller is doing stories in the newspaper on the fire department and the new fire house; those articles will be used for applying for grants. An RDA grant application was recommended. Langford Associates (Judy Langford) is to come discuss helping with write grant proposals. There are some foundations that may be receptive that have been identified. Board needs an engineer, an architect and a wish list.
